VISITOR WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT THIS IS AN IMPORTANT DOCUMENT THAT WAIVES YOUR LEGAL RIGHTS

The novel Coronavirus, COVID-19, has been declared a worldwide pandemic. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Although the Yavapai County Community College District ("College") has put in place protective measures to reduce the spread of COVID-19, the College cannot guarantee that you will not become infected with COVID-19. Your presence on campus or at a YC-sponsored event, together with other visitors, students and/or employees, inherently increases the risk that you and/or your household members will contract COVID-19, notwithstanding any precautions taken by the College.

I acknowledge the extremely contagious nature of COVID-19 and specifically assume all risks and hazards associated with my physical presence on campus or at a YC-sponsored event during the COVID-19 pandemic. I acknowledge that the College cannot absolutely control the conduct of all individuals at its locations or guarantee that others will follow safety protocols and procedures.

I further acknowledge that my physical presence on a College campus or at a YC-sponsored event is wholly voluntary. By my presence on campus during the COVID-19 pandemic, I voluntarily assume the risk that I may acquire COVID-19, and that COVID-19 may subsequently be transmitted from me to members of my household.

When at Yavapai College, I agree to comply with the following terms:

- 1. I will follow all COVID-19 protocols and procedures adopted by the College. This includes:
- a. I will wear Face Covers when on campus or at a YC-sponsored event, except when outdoors with adequate social distancing.
- b. I will maintain a distance of at least 6 feet from others at all times.
- c. I will not enter, or remain on campus or at a YC-sponsored event, if I have or develop any symptoms associated with COVID-19. I understand symptoms include, but are not limited to, fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting, and diarrhea
- 2. To the fullest extent permitted by law, I AGREE TO WAIVE, RELEASE, AND DISCHARGE ANY AND ALL CLAIMS, causes of action, damages, and rights of any kind against the College, its insurers, the College's governing board, and all of their respective employees, agents, representatives, and volunteers (the "Released Parties") arising from or relating in any way to any damage, injury, trauma, illness, loss, or death that may occur to me or my household members as a result of the COVID-19 pandemic.
- 3. I further AGREE NOT TO SUE THE RELEASED PARTIES, and to defend and indemnify the Released Parties for all claims, damages, losses, or expenses, including attorneys' fees, if a suit is filed concerning an injury, illness, or death to me or my household members as a result of the COVID-19 pandemic.
