II. New Business	 REC 105 is currently a Quickstart moving to a permanent course. The Committee discussed the frequency the course is offered each semester and enrollment information. The Committee reviewed the description in the proposal for the rationale for offering the course. The course is flexible and is built for different topics to be covered. It offers expansion for the recreation department.

 - MUS 221 was moved from the Consent Agenda to New Business because it is a Quickstart moving to a permanent, new course.
 - The Committee briefly discussed the title for the course, no changes made.
 - Approved unanimously.
- 3. Limited X-Ray Transition Certificate (Deletion)
- 4. RAD 160B (Deletion)
 - Tracy discussed the rationale for the program and course deletion. She reviewed the trajectory for the overall program next year.
 - Approved unanimously.
- 5. Detention Officer Training Academy Certificate
- 6. AJS 294
 - The Committee motioned to discuss the Detention Officer Training Academy Certificate and the AJS 294 course together.
 - Jason Ebersole gave a brief overview of the course and had updated the Learning Outcomes according to the Assessment Manager's suggestions.
 - The course is being supported by the Sherriff's office and can be completed in 8 weeks anytime during the calendar year.
 - The Committee members had questions about the lecture and lab hours in the course proposal. The Committee and Jason discussed the hours for the course, compared the variation in other AJS courses, and total time accumulation to complete the proposed course.
 - The Committee clarified the learning outcomes for the program. The learning outcomes were not included in the program proposal. Jason verified the learning outcomes should match the AJS 294 course proposal.
 - The Committee discussed the potential for registration overrides for programs over 18 credits. The current proposal for the program is 16 credits so it wouldn't require any overrides.
 - The Committee expressed concerns for the lecture and lab hours and how that would work with scheduling. Further discussion included concerns about scheduling with breaks to ensure proper time equivalency to credit hours in the course.

The Committee revisited the lab and lecture hours for credit and had an extensive conversation regarding contact and activity time while calculating for breaks. The Committee discussed the scheduling component and how hours and credits are calculated for courses. The Committee amended the motion to table the Detention Officer Training Academy Certificate and AJS 294 and to include the Law Enforcement Certificate, AJS 295 and AJS 292 so that credit lab and lecture hours could be worked on and reflect what is going to be done in the course and accurately scheduled.
