Chair Sigafoos called the Yavapai College District Governing Board meeting to order at 1:00 p.m.

Chair Sigafoos welcomed all guests and staff. The Board welcomed Prescott Fire Chief Dan Fraijo and recognized his leadership during the Doce and Yarnell Hill fires. Chief Fraijo addressed the Board and reported of the overwhelming support of condolences and charitable donations from across the world. He also acknowledged Yavapai College Fire Science program's contribution to education of the members of the Prescott Fire Department.

Dr. Wills reported on Yavapai College's role in assisting with the evacuations of the Doce and Yarnell Hill fires.

Mr. Oliphant moved, seconded by Dr. McCarver, to approve the Consent Agenda as written with the exception and removal of item #13. Motion carried unanimously.

13. Approval of Public and Charter School Dual Enrollment Intergovernmental Agreement with Yavapai College - RECEIPT, DISCUSSION, AND/OR DECISION (refer to Board packet, pgs. 32-53) Item #13 was pulled from the Consent Agenda and discussed under the Regular Agenda. Dr. Wills introduced the new Dual Enrollment IGA template as attached, and a listing of schools that will participate in the program. Lynne Adams confirmed that this is an IGA template that is being used across the state of Arizona in all Community Colleges, and has received the approval of the College's attorney. Mr. Oliphant stated his concerns with the language and some of the requirements of the agreement. Chair Sigafoos advised Mr. Oliphant that his comments are beyond the Board's duties and held his comments out of order. Dr. Wills requested that the College not lose track of the essences of the program, and she emphasized the importance to the schools and our community.

Dr. Fitzner moved, seconded by Dr. McCarver, to approve the Public and Charter School Dual Enrollment Intergovernmental Agreements with Yavapai College. Motion carried with four yes votes and one no vote from Mr. Oliphant.

 applications, and the interviews are scheduled to begin in September 2013.
 - Yavapai Combined Trust Rose Hurley provided the YCT quarterly report. She highlighted pages 6 and 7 of the handout, and credited the program's success to an effective management plan. The Trust has had no increase in premiums for 2 years. Mr. Harrington congratulated the YCT committee for an outstanding job. (refer to handout "YCT Plan Contribution and Expense Report")
 - Capital Improvement July 2013 Attached Dr. Wills highlighted the renovation of the residence hall and several CTEC classrooms. The Board will tour the CTEC facility following meeting.

The Smith Group will create a ten year campus plan with input from community and employee forums, and working with a College Steering Committee. The Smith Group will be presenting three proposed plans the week of August 8th to the Steering committee and Executive team. Dr. Wills is meeting with all Mayors in Yavapai County to inform them of an opportunity for input at a September session. Dr. Ewell requested that the Board also schedule a work session with the Smith Group in September 2013. Campus Master Plan's final target date is November 2013.
