A 10-minute recess was taken to collect document signatures before proceeding to the District Governing Board Regular Meeting following the conclusion of the Budget Adoption Meeting.

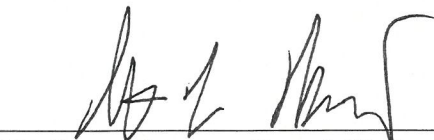

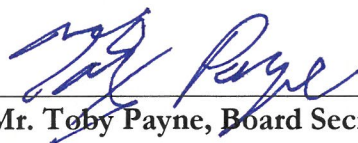
