2019-2020 CAPITAL IMPROVEMENT PLAN

Renovation of Building L

Interior work consists of metal stud framing of the second floor and installation of ductwork, hot/chilled water piping that will tie the HVAC back to the central plant. Electrical rough-in is in process for both the first and second floor. Second floor framing has begun for the simulator and debrief rooms along with new classrooms. Mechanical units and supporting piping are being installed throughout the building.

Exterior work continues with the completion of roof drainage as excavation continues for additional foundation work to support the building expansion. Final fire marshal review is underway concerning underground piping to support the new sprinkler system. As soon as the new line is installed and approved by the fire marshal, lot 10 will be available for more parking.

Access to the greenhouse remains open.

CTEC – Clean Fabrication Area

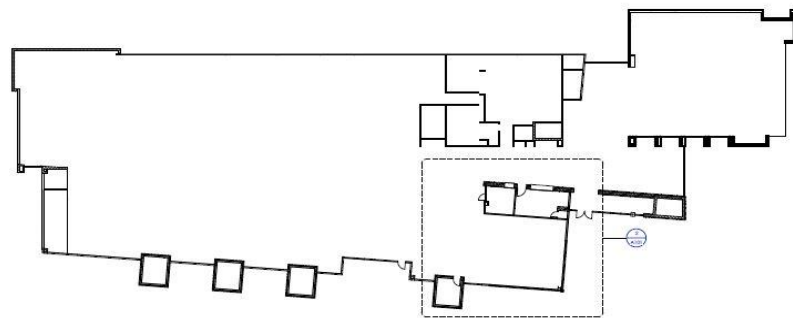

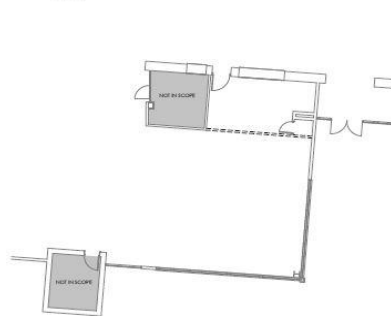
OVERALL NEW FLOOR PLAN

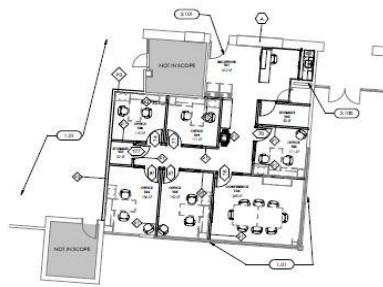

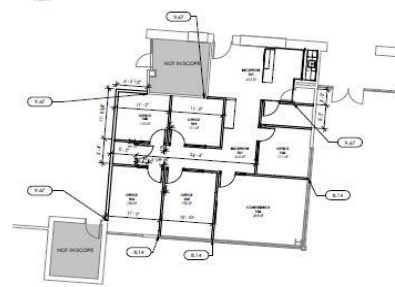

BUILDINGS AND GROUNDS PLANNED MAINTENANCE PROJECTS

As part of the budget, planned maintenance projects are scheduled each year to ensure that College facilities and grounds are maintained at a level to support optimum performance in building systems, infrastructure, life safety, roadways, and parking. These projects are the result of a recent Facilities Condition Assessment (FCA), which identifies when repairs, modifications, or replacement of components should occur.
